

The estate became involved in protracted litigation in the federal courts, in which J. H. Rhodes, defendant in error, was employed as attorney for the administrator, and he acted1 in that capacity in that litigation, and also rendered such other legal services as were desired by the administrator. In August, 1880, the administrator filed an account, which showed assets in his hands amounting to \$1,223.85. This account was approved. On May 12, 1897, the administrator filed an account of the expenses of administration, being for the administrator personally, \$782.50, and for his attorney, J. H. Rhodes, \$527.25. These exjenses were itemized, showing in detail the nature and amount of each item. Mrs. E. K. Byrnes, one of the creditors of the estate, filed exceptions to the account of the administrator, which were afterwards withdrawn, and on October 11, 1897, the expense account was approved and confirmed as presented and filed; and the administrator was ordered to file his final settlement without delay, which was done on October 26,...
